To create a basic P&L manually, take the following steps:

Gather necessary information about revenue and expenses (as noted ab) Tj T* BT

List your sales. ...
List your COGS.
Subtract COGS (Step 3) from gross revenue (Step 2). ...
List your expenses. ...
Subtract the expenses (S) Tj T* BT
